

Dear Judge Lasker:

We received this morning a copy of Mr. Carberry's letter to Your Honor dated June 15 and the Government's proposed Order.

As we urged in the brief that we filed in this matter, we believe secrecy is appropriate only insofar as it is "essential" to preserve higher values." Press Enterprise Co. v. Superior Court, 464 U.S. 501, 510 (1984). We are writing to express our concern that the proposed Order merely states possible advantages in maintaining in secrecy material omitted in Mr. Carberry's redaction of the plea agreement without finding that such redaction is "essential" and without identifying the "higher values."
